To be eligible to participate in the election, D.C. Code required participants to possess a degree (associate's, baccalaureate, or graduate) from UDC, UDC Community College, the David A. Clarke School of Law, or our legacy institutions: Miner Teachers College, Wilson Teachers College, D.C. Teachers College, Federal City College, the Washington Technical Institute, and Antioch Law School. It also required nominees to obtain 25 signatures from other alumni to appear on the ballot. Yes Elections, the external vendor managing the election process, received nominations for 55 alumni who did not appear on the ballot. We thank those Firebirds for their interest in serving the University.

Yes Elections received 443 ballots by mail, and 632 ballots via the online portal. In total, Yes Elections received 1,075 ballots. Since each alumnus was able to vote for up to three candidates, the total number of votes (2,730) is greater than the number of ballots.

The deadline to protest the election results is Monday, July 27, 2020, at 5:00 pm (EDT). Those who voted in the election are eligible to submit protests to my office. Enclosed please see the instructions for submitting protests.

Please stay connected, and consider remaining involved. We are a legacy institution of the District of Columbia created and sustained by extraordinary citizens who have rich histories of excellence. The University needs your advocacy, volunteerism, and philanthropy to continue to grow and to stay strong.
