SUBJECT: APPOINTMENT OF SHIELA HARMON MARTIN, PH.D., COLLEGE OF ARTS & SCIENCES, AS PROFESSOR EMERITA

**WHEREAS**, pursuant to D.C. Official Code 38-1202.06, the Board of Trustees (the "Board") of the University of the District of Columbia (the "University") has responsibility to generally determine, control, supervise, manage, and govern all affairs of the University, including oversight of faculty; and

WHEREAS, pursuant to 8 DCMR § 1412.1, the title of Professor Emeritus may be conferred by the Board of Trustees upon a retired member of the faculty who has rendered distinguished service to the University; and

WHEREAS, the Interim Chief Academic Officer and the Acting Dean of the College of Arts and Sciences have recommended that emeritus status be conferred upon Dr. Shiela Harmon Martin in recognition of her range of contributions to the academic pursuits and the community of the University, pursued with dedication, integrity, and energy; and

WHEREAS, Dr. Harmon Martin's 49-year tenure on the faculty of the University was marked by distinguished contributions to the discipline of political science and to the University of the District of Columbia (UDC) as a professor; educational administrator; faculty leader; scholarly researcher (including the areas of health policy issues, program performance evaluation, Black women, and related political issues); principal investigator of both private foundation and government funding grants; mentor to students and colleagues alike; and

WHEREAS, Dr. Martin served on loan to a presidential administration and two (2) District of Columbia Mayoral administrations; in addition to the numerous professional awards and recognitions over the decades for exemplary teaching, research, leadership and service to the political science profession both within and outside the University community; and

WHEREAS, the Board has received and reviewed the supporting documentation and agrees with the nomination of Professor Martin for the reasons described therein and commends Professor Martin for her distinguished service and professional excellence.

**THEREFORE, BE IT RESOLVED** that in recognition of Dr. Harmon Martin's long and committed service to the University, the City, and her profession in the areas of teaching, research, and service, the Board of Trustees hereby confers upon Dr. Shiela Harmon Martin the title and position of Professor Emerita, with all the rights, privileges, and responsibilities pertaining thereto.

# RECOMMENDATION AND JUSTIFICATION-PROFESSOR EMERITUS STATUS DR. SHIELA F. HARMON MARTIN

As Chair of the Division of Social and Behavioral Sciences, College of Arts & Sciences, I strongly recommend Dr. Shiela F. Harmon Martin for the status of Professor Emeritus, University of the District of Columbia. Dr. Harmon Martin retired on August 15, 2023, after serving the University of the District of Columbia and its predecessor institution, Federal City College (FCC) with honorable distinction for 49 years. The authority for the UDC Board of Trustees to grant Professor Emeritus status derives from 8 DMRC 1412.1 and therefore, I am initiating this process under its purview.

During her 49 years of service at the University, Dr. Harmon Martin performed the roles of faculty, department, and division chairpersons. She represented the University, on loan, to a presidential administration and two (2) District of Columbia Mayoral administrations. She was the recipient of numerous grants that contributed to the growth and development of faculty and students while serving the residents of the District of Columbia. Lastly, hundreds of UDC students are the seeds of her outstanding teaching and mentoring and they continue to sow her legacy through their contributions to the District, the nation and their global communities. Dr. Harmon Martin's contributions to the University and its footprint locally, nationally, and internationally are eminently deserving of recognition as Professor Emeritus. I am confident that the following testimony of her accomplishments, in areas of teaching, academic leadership, professional productivity, and service to the University, DC community, and nation, throughout her 49-year tenure at the University of the District of Columbia will also ensure your approval of this recommendation.

### EDUCATIONAL BACKGROUND

Dr. Shiela F. Harmon Martin was awarded the Bachelor of Arts degree in Political Science from Southern University A. & M. College, Baton Rouge campus. During her undergraduate studies she studied abroad in St. Gallen, Switzerland and attended the Washington Urban Semester Program, American University, Washington, DC and interned in the Office of US Senator Edward W. Brooke, of Massachusetts. She also obtained both the Master of Arts (Atlanta University) and the Doctor of Philosophy degrees (Clark Atlanta University) in Political Science. Dr. Harmon Martin's graduate studies in Political Science included numerous internships in local (Atlanta) and national (Office of Telecommunication Policy, Executive of the White House) governmental agencies.

### **ACADEMIC TEACHING**

Dr. Shiela F. Harmon began her academic career as an Assistant Professor of Political Science at Federal City College in 1974 and completed the rank of Professor. Her academic teaching areas of expertise were the discipline subfields of American Government, Urban Politics, Public Administration and African Politics. She taught numerous courses in these subfields throughout

her academic career as well as a graduate course focusing on Health Policy in the College of Arts and Sciences.

As faculty and to expand her public policy knowledge, Dr. Harmon Martin 's was selected for two (2) intergovernmental policy assignments with the following federal and local government agencies.:

• Special Assistant, Office of Policy, Urban Mass Transportation Administration, Department of Transportation (Presidential Administration-Ronald Reagan).

Duties: Served as a principal advisor to the Director, Office of Policy, on matters related to policy formulation and research for urban mass transit programs. Performed program reviews and managed several research contracts. Member of speech writing team for the Administrator (presidential appointee). Represented administrator and supervisor at meetings and conferences relating to transportation policy.

• Special Assistant for Protocol & International Affairs, Office of the Secretary, Executive Office of the Mayor.

Duties: Served as the official representative and primary liaison for the city government with the diplomatic community for both ceremonial and substantive matters during the Mayoral Administrations of Marion Barry and Anthony Williams. Prepared correspondence, briefings, and official reports relating to international affairs. Monitored (3) three sister city councils. Planned, coordinated, and advanced international travel for Mayor.

Awarded outstanding performance rating:

Dr. Harmon Martin also was the recipient of two travel fellowships designed to study the history and culture of Cuba and Korea.

- Freeman Seminar Fellow, Center for Korean Studies, University of Hawaii, June July 2005. Travel and study grant to Korea to study the history and culture of Korea.

Dr. Harmon Martin utilized all these opportunities to integrate knowledge acquired into the content of her academic courses.

#### ACADEMIC LEADERSHIP

During Dr. Harmon Martin's Federal City College tenure, she was appointed interim Chair of the Department of Political Science (Summer 1977-Fall semester 1978) during a departmental leadership transition period. However, her extensive UDC administrative leadership journey began in 1999 when she was appointed and served as Chair of the Department of Urban Affairs, Social Sciences and Social Work (UASSSW). A multi-discipline unit, UASSSW consisted of the undergraduate academic programs of Criminal Justice, History, Political Science, Social Work, Sociology, Urban Studies; Homeland Security, graduate program; and a Non-Profit Leadership Certificate program. Dr. Harmon Martin masterfully displayed her leadership skills through her management of a faculty of over thirty-five (35) full-time and adjunct faculty and approximately six hundred majors. She chaired UASSSW from 1999 until 2010 when it was reorganized by the University's Board of Trustees into two units-The Department of Political Science, History & Global Studies (PSHGS) and The Department of Urban Affairs, Criminal Justice & Social Work. Dr. Harmon Martin served as Chair of PSHGS until 2014. Upon reorganization of the College of Arts and Science into divisions, she was appointed and served as the Chair of the Division of Social & Behavioral Sciences (DSBS) from 2014-2019. DSBS consists of the academic programs of Crime, Justice & Security Studies, Human Development, Political Science, Psychology and Homeland Security (graduate). Dr. Harmon Martin's departure from academic leadership in 2019 marked 20 years of administrative leadership in the College of Arts and Sciences (CAS) and the longest tenure of an academic chair during this period.

Throughout her 49-year tenure, Dr. Harmon Martin not only achieved a substantive leadership and service record, but she also continuously taught both undergraduate and graduate courses.

As Chair of the Department of Urban Affairs, Social Sciences & Social Work, Department of Political Science, History & Global Studies, and Division of Social & Behavioral Sciences, the following represents a brief synopsis of Dr. Harmon Martin's accomplishments.

- Actively engaged department faculty in the institutional self-study process, an integral component of the UDC reaffirmation of accreditation process by the Middle States Commission on Higher Education. Many faculty held leadership committee positions during several self-study processes.
- Coordinated with the Program Directors and faculty, the re-accrediting and accrediting process for the Social Work program (Council on Social Work), Social Studies /History Education (National Council of Accreditation of Teacher Education) and an external participant for the accrediting of Rehabilitation Counseling (Council on Rehabilitation Education).
- Coordinated the self-study of academic programs (Criminal Justice, History, Human Development, Homeland Security, Political Science, Psychology, Sociology, Sociology, Social Work, and Urban Studies, (several times) during tenure as Chair.
- Established, in collaboration with the DC Sister Cities Program, Office of the Secretary, Executive office of the Mayor, the UDC University of Sunderland (US), Sunderland, England Study Abroad Program. Three (3) UDC students studied at the University of Sunderland and two

- (2) US students attended UDC. Dr. Harmon Martin represented UDC in the City of Sunderland, England-Washington Steering Committee, DC Office of the Secretary.
- Financially supported and encouraged faculty research, professional development, and online teaching through the University's Research Academy for Integrative Learning (RAIL) program and other faculty training programs, through attendance and presentation at discipline related conferences, and mentorship.
- Financial supported and encouraged active participation and attendance at annual conferences/meetings of discipline-related professional associations of all faculty and students. Dr. Harmon Martin, specifically, consistently prepared students to present their academic research at the National Conference of Black Political Scientists (NCOBPS) annual meeting. Students presented at meetings held in Atlanta, Georgia, Wilmington, Delaware, Las Vegas, Nevada, Baton Rouge, Louisiana, Baltimore, Maryland, Arlington, Virginia, and Washington, DC. Six (6) students, who presented at the Wilmington, Delaware meeting, were featured on the American Political Science Association website for their undergraduate research.
- Supported the activities of students, including organizations, honor societies, scholarships, and internships. Held honorary induction ceremonies for all majors.
- Administered Teach Out Plans for students in the Urban Studies (2011), History (2014), and Sociology & Anthropology (2014) programs due to program discontinuation resulting from Board of Trustees resolutions.
- Coordinated, in conjunction with the Program coordinator, Crime, Justice & Security Studies program, the smooth transition of the Associate Degree programs in Corrections Administration (AAS) and Law Enforcement (AAS) to the UDC Community College.

Appointed Director of the UDC Center for Applied Research & Urban Policy (CARUP) while concurrently serving as Division Chair. She coordinated and was awarded a \$300,000 Memorandum Agreement with the DC Office of the State Superintendent of Education, "To conduct the 2012 DC Childcare Market Rates and Capacity Utilization Study". Under the auspice of CARUP, Dr. Harmon Martin also received a \$50,000 grant from The Urban Institute, for faculty and students to participate in a summer project (2016) conducting a "Needs Assessment of DC Public Housing, for the DC Public Housing Authority.

### **UNIVERSITY SERVICE**

Dr. Harmon Martin has been a dedicated servant leader throughout her tenure at Federal City College and the University of the District of Columbia at all levels-department, college, and university. Examples include the following:

- Elected to the first Faculty Senate, chartered by the BOT in 1980, as representative of the Department of Political Science. Also served on the FS, academic year 2020-2021.
- Served as a member of the CAS Council of Chairs (1999-2019) and perform leadership roles in numerous activities such as staff appreciation activities, Curriculum Committee, Undergraduate

Research Day, Faculty Hiring Committee, CAS General Education Committee, Sabbatical Committee, and numerous other assignments as requested by the Dean.

- As faculty, served on department committees including Promotion and Evaluation, Student Affairs, Amenities, Curriculum, Student Grievances and Appeals; coordinated faculty dinners (during FCC tenure); sponsored monthly departmental lecture series featuring DC politicians, congressional staffers, community activists and professionals.
- University service included membership and leadership roles on numerous committees, including, but not limited to, University Assessment Committee (2015-2019), UDC Veterans' Observance Committee (2014-2016), University General Education Committee (2010), Chair of CAS Dean Search Committee, Chair of UDC Commencement Exercises Committee, Honorary Degree Committee. She also served as a member of the Advisory Board of the Initiative in Civic Engagement & Equity, (ICE-E), a university-wide summer internship program.

Dr. Harmon Martin has been the recipient and principal investigator of both private foundation and government funding grants totaling 1.340 million dollars. She has also served as a research associate on numerous research projects in CARUP beginning in 1990 and as a community based social science researcher at the UDC- Lombardi Cancer Control Center, Georgetown University project under the auspices of U-56, National Institute of Health Grant. In 1988, Dr. Harmon Martin was the first UDC faculty to receive a grant from the Ford Foundation in the amount of \$190,000. She developed and produced a satellite videoconference series on "Political Empowerment: The Black Vote and Implications for the Future" that was programming for colleges and universities.

#### Conclusion

The proposed resolution is for the title of Professor Emerita which may be conferred by the Board of Trustees upon a retired member of the faculty who has rendered distinguished service to the University and the community of the District.

### **Background**

The Interim Chief Academic Officer and the Acting Dean of the College of Arts & Sciences (CAS) of the University of the District of Columbia, have recommended that Emerita status be conferred upon Shiela Harmon Martin, Ph.D., retired Professor of Political Science.

This status is awarded in recognition of the Professor's wide range of contributions over the past 49 years to the academic pursuits of the University (including its predecessor Federal City College) and for her service to the University community and beyond. The award of emerita status is advocated for Professor Harmon Martin due to her distinguished academic career, which included serving as faculty, department, and division chairpersons, in addition to her contributions while on loan to a presidential administration and two (2) District of Columbia Mayoral administrations. She is especially cited for her hundreds of UDC students who experienced her outstanding teaching and mentoring and who now continue to sow her legacy through their contributions to the District, the nation and their global communities. She has continued her commitment to UDC into her retirement, in a formal volunteer position to help oversee and transition a grant that she secured for the Political Science program from the District government.
