WHEREAS, Dr. Botao Chen, Ph.D., Associate Professor in the Department of Accounting & Finance in the School of Business & Public Administration (SBPA) of the University of the District of Columbia (University), has petitioned the University to be granted tenure in the department in which she is qualified; and

WHEREAS, pursuant to 8B DCMR §1462, Dr. Mohamad Sepehri, Dean of SBPA, in conjunction with the Department of Management faculty and the SBPA Promotion and Tenure Committee, have all conducted a thorough review of Professor Chen's academic background and records of achievement in teaching, scholarship, and university and community service and have recommended her for tenure at the rank of Associate Professor; and

WHEREAS, they judged Professor Chen to be an exemplary teacher (at both the undergraduate and graduate levels) with the knowledge and skills in her field who meets the criteria by which University of the District of Columbia faculty are evaluated, based on the 8th Master Agreement, including her teaching effectiveness, emerging research and scholarly works, expertise, and community engagement, all of which make her an asset to UDC; and

WHEREAS, the Chief Academic Officer and the President have affirmed the recommendation of tenure for Professor Chen from Dean Sepehri, the Department of Management faculty and the SBPA Promotion and Tenure Committee, and the President has forwarded the recommendation for tenure to the Board of Trustees.

NOW THEREFORE BE IT RESOLVED, that the Board of Trustees of the University of the District of Columbia approves the award of tenure to Botao Chen, School of Business & Public Administration, at the rank of Associate Professor.

President Mason:

Guided by the *Eight Master Agreement* and criteria established by the School of Business & Public Administration (SBPA) for promotion and tenure, I have reviewed the portfolio and supporting documentation submitted by **Dr. Botao Chen for tenure**.

As Chief Academic Officer, my review aims to evaluate evidence of significant and relevant achievements in scholarship/creative work, teaching, and service. In addition, I review the self-narrative to ensure alignment between established standards and evidence provided within the portfolio. I review each applicant after the files have been reviewed by the Chair, DEPC, CPC, Dean, and URC (in cases where an appeal is filed). Based on a holistic review of recommendations and the file, I make an independent recommendation to you for consideration.

Professor Chen was appointed tenure-track Associate Professor in August 2019 with only two years of credit toward tenure. Professor Chen is now applying for tenure. For two of the past three years, she has received annual evaluation cumulative scores of 4, 3, and 3.

TEACHING: The **SBPA Promotion and Tenure Committee** states, "The portfolio shows exemplary teaching activities at UDC, at both the undergraduate and graduate levels, including many extracurricular SBPA-related activities." The **Chair** observes, "Dr. Chen has taught successfully across five courses, including two graduate courses, and her teaching evaluations have shown improvement and consistency. [...] In addition, Dr. Chen's teaching matches directly to AACSB's mission where she (1) **engages** her students in the classrooms, (2) **innovates** using cutting-edge technologies and current industry trends, and (3) provides **impact** on her students." In her narrative, Professor Chen states that in her classes, "students had more opportunities to complete their assignments. Furthermore, I provided enough supplemental materials for different levels of students. Through virtual office hours, students were welcome to discuss the material and seek help." Commendably, Professor Chen then addresses her teaching according to the three areas of achievement/performance dictated by AACSB standards: engagement, innovation, and impact. This proves to be an effective rubric for assessing teaching effectiveness. Two specific

impacts listed in the narrative speak to closing the loop: "Group term-project presentations made MBA students improve teamwork, communication, and presentation skills"; and "Students were more confident on CPA exams and their career plans after taking my classes." Her course-end evaluations since 2019 average approximately 3.7 out of 4. She meets the standard in this domain.

RESEARCH: The SBPA Tenure & Promotion Committee states that Professor Chen's "portfolio demonstrates a superior scholarly and research productivity in terms of published peer-reviewed journal articles, in a variety of scholarly journals, and conference presentations. Commendably, Dr. Botao Chen published five peer-reviewed journal articles in the past five years and presented at over 10 national/international conferences in her field." Professor Chen provides evidence of publication in the following journals: Global Journal of Accounting and Finance, Journal of Finance and Accountancy, and Accounting and Finance Research. Professor Chen identifies in her narrative certain journals as being listed with the ABDC (Australia Business Dean Council) list of journals. SBPA appears to favor publishing in AABRI journals since those journals contain the papers/proceedings from the annual conferences of AABRI. In Professor Chen's case, three papers fit this category (all published in the Journal of Finance and Accountancy). Finally, Professor Chen's portfolio indicates that she has not applied for any grants as a PI or Co-PI. Based on the publications, Professor Chen's performance in this domain marginally meets the standard.

SERVICE: The **Chair** commends Professor Chen for her service "at all levels: university, school, and department, participating in committees at different levels, such as SBPA Graduate Curriculum Committee, SBPA Assessment of Learning Committee, etc. She is also the founding member of the MSA Program Committee and a member of the DEPC. At the university, Dr. Chen represented SBPA as a faculty senator. She has participated in a few faculty searches for accounting and/or finance." Professor Chen also provides service to the profession as a peer reviewer for "several accounting journals and has "served as a coordinator and discussant for several American Accounting Association conferences" At the university level, Professor Chen has served on two Faculty Senate committees: Finance and Research. There is no other university service listed in the narrative.

Summary Evaluation

To her credit, Dr. Chen does provide six external letters of support from the following reviewers: Bobbie W. Daniels, Ph.D., CPA, CGFM, Jackson State University; Adrian L. Mayse, Ph.D., CPA, Howard University; Kayla Booker, Ph.D., CPA, Rhodes College; Deging Li, Ph.D., University of Maryland Eastern Shore; Lydia Didia, Ph.D., CPA, Jackson State University; and Harold Lundy, Ph.D., Florida A&M University. I will quote only three of these. Dr. Daniels "highly recommend[s]" Dr. Chen for tenure and calls her "a gifted researcher and talented teacher who will be even more productive in the future." Dr. Booker writes, "I strongly believe that Dr. Chen is exceptionally well-qualified for tenure and will be a long-term asset to your department and school." Similarly, Dr. Mayse offers praise and a positive recommendation: "Dr. Botao Chen has demonstrated outstanding achievement in teaching, scholarship, and university and community service. She has proven to be an impact, innovative [sic], and engaging scholar. I highly recommend Dr. Botao Chen, CPA, for tenure." SBPA reviewers enthusiastically endorsed this application. The **Dean** sums up his evaluation this way: "Dr. Chen has been one of our most valuable and contributing faculty since she joined the UDC-SBPA. Her tenure application portfolio exhibits a combination of exemplary intellectual contribution and research scholarship, teaching excellence, commitment to students, and dedicated service to the school and the university." Professor Chen went the extra step of obtaining external review letters. The portfolio itself is well organized, but it feels somewhat light regarding overall contributions and performance record. I would encourage Professor Chen to pay closer attention to her publication placements and service engagement in the future as she considers an application for future promotion. I concur with all recommendations in supporting Professor Chen to earn tenure.

Conclusion

It is concluded that there is no fiscal impact associated with the granting of tenure to Dr. Botao Chen, Associate Professor in the Department of Accounting & Finance, School of Business & Public Administration (SBPA) of the University of the District of Columbia (UDC). The proposed resolution is for the approval of tenure for Professor Chen at her current rank of Associate Professor.

The SBPA's Promotion and Tenure Committee and the Management Department faculty have conducted thorough, independent reviews and prepared independent reports to the dean regarding tenure for Professor Chen. It was then considered at the Dean's, CAO's and President's levels. It has been recommended in the Board Resolution that Professor Chen be approved for tenure.

Background

Dr. Chen joined the SBPA in August of 2019 and received a two-year credit toward the tenure-track timeline as part of her appointment as an associate professor. Professor Chen's tenure application examined her performance in the areas of teaching, scholarship, and service. Vetting of all dossier content was completed at the levels of the program, Department, and School. The CAO reviewed all recommendations and Dr. Chen's portfolio. All reviews validate the strengths of Professor Chen's tenure dossier and conclude that she is an exemplary teacher and an emerging scholar and researcher, making her a very competitive tenure candidate. Additionally, she has demonstrated an adequate record of service to the University community.

The recommendation of tenure for Professor Botao Chen has been affirmed by the Dean, Chief Academic Officer, and President. The President has forwarded the recommendation and background information along with a resolution for the award of tenure to the Board of Trustees.
