Todd previously worked in the Council office of Muriel Bowser and in various campaign positions during her successful campaign for Mayor of the District of Columbia. Todd won a special election in May 2015, succeeding Muriel Bowser, who was

elected as mayor. After serving one full term on the council, Todd left office on January 2, 2021. Todd is currently Director, Corporate Public Policy for Washington Gas.
