### What is an F-2 Dependent?

F-2¹ status holders are dependents of F-1 status holders who are accompanying in the F-1 during their studies or Optional Practical Training (OPT) period. They are either a **Spouse** or **Children under the age of 21.** F-2 status follows the F-1 status for the duration of stay (D/S). Each F-2 is issued an individual I-20.

#### F-2 status Benefits and Limitations

- F-2's can participate in activities that are incidental to their status (e.g., part time language study, art classes, recreational activities)
- F-2's can study <u>part-time</u> in a degree program<sup>2</sup> (F-2 enrollment in Public Kindergarten through 12th grade study is not subject to the part time limit).
- F-2's can travel with or without the Primary F-1 student
- F-2's are not permitted to engage in employment (on or off campus) and are not eligible for USCIS work authorizations
- F-2's are eligible for Change of Status<sup>3</sup> to F-1 if planning to pursue full time study at a language school or higher education degree program.

How to Apply for an F-2 I-20					
Either an Initial or Active F-1 student may apply for F-2 Dependent I-20's. The following should be submitted to International Student Services (ISS):

2.	Proof of Identity Documents	Documents that confirm the identity of the dependent. Must be in English or with an official English translation  • Passport/Official Government Issued Travel Document			
3.	Proof of Relationship Documents	Documents that confirm the relationship to the F-1 (spouse or minor child).  Must be in English or with an official English translation  Marriage Certificate  Birth Certificate  Proof of Guardianship or Adoption			
4.	Proof of Funding	Evidence that the there is sufficient funds to provide for the dependent's living and personal expenses while in the U.S., Must be in English or with an official English translation.  • \$3,000 USD for the first dependent  • \$2,500 USD for each additional dependent
