Consys, Inc., hereinafter referred to as "the Contractor", and The Board of Trustees of the University of the District of Columbia, hereinafter referred to as the "University," mutually agree as follows:

The University, in consideration of the proposal price in the amount of one million four hundred ninety-seven thousand seven hundred eighty six dollars and zero cents (\$1,497,786.00) enters into this firm fixed price contract with Consys, Inc., for the Building 46E, Theater Lighting Upgrades.

The University, represented by the Office of Strategic Sourcing and Procurement executing this contract, and the Contractor, mutually agree to perform this contract in strict accordance with the contract document, including the Solicitation, the Contractor's proposal, and the District of Columbia Standard Contract Provisions for use with District of Columbia Government Construction Projects, March 2011. These documents are incorporated herein by reference and made a part hereof.

The following addition to the contract is hereby stipulated and agreed to by the parties hereto:

A. General Provisions

1. Time for Completion

Work shall commence on the date specified in a written Notice to Proceed to be issued by the Office of Strategic Sourcing and Procurement and shall continue <u>WITHOUT INTERRUPTION</u> until completion and acceptance. The contract shall be completed within one hundred and twenty (120) calendar days after such notice.

2. Liquidated Damages

The Contractor shall pay to the District the sum of four thousand one hundred forty-five dollars and zero cents (\$4,145.00) as agreed liquidated damages for each calendar day of delay in completion of the work for this project, within the time limits set forth, subject to provisions of Article 5, DELAYS, of the General Provisions of the Standard Contract Provisions for Construction Projects, March 2011.


